Artist applications and art proposals, as well as any exchanges (questions, data) must be sent through the state procurement platform (link above), in order to comply with security, tracking, reporting requirements.

## **Background :**

As part of the 1% for art program and the obligation of decoration of public buildings, the DDTM du Morbihan is seeking proposals for a public art installation for their building named « Troadec » and located in Vannes.

The funds allocated under the 1% for art will be used for the creation of an art work inside the building (interior patio and/or interior walls) and/or outside. The art work can also be on the exterior facade.

The art work will have to take into account the historical context of the DDTM, which took over some of the functions of the former Direction Départementale de l'Équipement (Public Works), Direction Départementale de l'Agriculture et de la Forêt (Agriculture and Forestry), Direction Départementale des Affaires Maritimes (Sea & Maritime Affairs). DDTM is a government agency with significant local presence and impact in the regions in which it undertakes technical and administrative duties.

It works with elected officials, citizens and numerous local businesses and stakeholders (farmers, fishermen, shellfish farmers, public housing authorities, driving schools, ...).

All art forms are welcome. It could be photographs, paintings, sculptures or any other type of artwork.

## **Budget for this project :** 92 000 € TTC.

This amount includes:  
- a payment for the winning artist and copyrights fees;  
- the design, construction and installation cost of the artwork

- a compensation fee for unsuccessful candidates,
- advertising and other administrative costs (per diem and travel expenses for committee members).
